**APPROVING MUNICIPAL RESOLUTION NO. 480, S-2021 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED, "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 01 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its SB Resolution No. 480, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Development Councils of Southern, Central and Western Districts Lingayen, Pangasinan through MDC Resolution No. 01, Series of 2021, dated June 15, 2021, has endorsed the realignment of various projects under the 20% Local Development Fund CY 2021 to new development projects. This is embodied in the municipality's Supplemental Investment Program No. 01 which was endorsed through MDC Resolution No. 02, Series 2021 to the Sangguniang Bayan for approval;

**WHEREAS**, the said Supplemental Investment Program No. 01 of the municipality with an investment requirement amounting to Php63,400,782.44 covers the implementation of new development projects and fund augmentation for the disaster risk reduction and management programs and maintenance and other operating expenses and capital outlays of various offices in the municipal government;

**WHEREAS**, the Supplemental Investment Program No. 01 also includes list of programs/projects proposed to be funded by external sources;


