PROVINCIAL RESOLUTION NO. 799-2020

**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM
NO. 7 OF THE PROVINCE OF PANGASINAN FOR CALENDAR
YEAR 2020**

WHEREAS, presented for consideration is the Supplemental Investment Program No. 7 of the Province of Pangasinan as endorsed by the Provincial Development Council thru PDC Execom Resolution No. 09-20;

WHEREAS, Supplemental Investment Program No. 7 contains other priority programs, projects and activities that are not included in the approved 2020 Provincial Annual Investment Program of Pangasinan;

WHEREAS, the Supplemental Investment Program No. 7 shall cover the granting of CY 2019 Performance Based Bonus to all qualified officers and employees of the Provincial Government pursuant to DILG-DBM Joint Memorandum Circular No. 2019-01 dated November 21, 2019; fund augmentation for the operation of various provincial offices and hospitals; and Purchase of Lot in Mabini and Bautista, Pangasinan intended for the Satellite Multi-Purpose Building of the Province to be funded from the unappropriated surplus and reversion of current appropriations in the amount of P66,822,200.00;

WHEREAS, there is also a need to realign some programs/projects in the previously approved Supplemental Investment Program No. 1, CY 2020 from: *Skills Training in Support to the Mobile Training Program of the Province and Skills Training for Livelihood Projects* to: Abig Pangasinan programs and projects, namely: *Purchase of Livestock/Poultry for Dispersal as Additional Livelihood and Establishment of Food Processing Center*, respectively; and also realigned the Tourism Activity Fund amounting to P3,000,000.00 from the previously approved AIP 2020 to fund the ABIG Helping Economies at Local Spots (HEALS) Program and include these programs/projects in Supplemental Investment Program No. 7;

WHEREAS, the *Purchase of Livestock/Poultry for Dispersal as Additional Livelihood* is proposed to be funded from the available DOE ER 1-94 Development and Livelihood Fund (DLF) (P9,000,000.00) and realigned DOE ER 1-94 of Sual Coal Fired Thermal Power Plant (P1,000,000.00) while the *Establishment of Food Processing Center* will be funded from realigned DOE ER 1-94 DLF of San Roque Power Plant (P3,000,000.00) and realigned Cooperative Development Fund CY 2020 (P1,000,000.00);

WHEREAS, also included in this Supplemental Investment Program No. 7 are details of various infrastructure projects in addition to the programs and projects already included in the Annual Investment Program CY 2020 of the Province of Pangasinan under 20% Development Fund/Non-Office;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;

WHEREAS, after careful study of the said Program, this august Body finds it to be in order;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan of Pangasinan to approve, as it is hereby approved, the Supplemental Investment Program No. 7 of the Province of Pangasinan for Calendar Year 2020;

RESOLVED, FINALLY, that copies of this resolution be furnished to the Department of Budget and Management thru the Provincial Budget Officer and all authorities concerned, for their information and guidance.
