## **RESOLUTION NO. 799-2021**

DECLARING MUNICIPAL ORDINANCE NO. 3-2021 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ILLEGAL GAMBLING IN ITS VARIOUS FORMS IN THE MUNICIPALITY OF URBIZTONDO, PANGASINAN AND IMPOSING CHARGES ON VIOLATORS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Ordinance No. 3-2021to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
