ORDINANCE DECLARING NO. 149, S-2020 **OF** THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE OPERATIONALIZING **FREEDOM** INFORMATION IN THE MUNICIPALITY PANGASINAN AND PROVIDING GUIDELINES THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG **BAYAN TO ENACT**

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 149, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Article III, Section 7 of the 1987 Philippine Constitution and Section 447 (a) (x) of RA 7160;

WHEREAS, however, reminder is made that the institution of administrative cases against an erring government employee or official must be in accordance with the applicable provisions of the Administrative Code and the Local Government Code;

WHEREAS, subject ordinance shall take effect after the legal requirements laid down in Sections 187, 188 and 59 of RA 7160 are complied with;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was
