**APPROVING MUNICIPAL RESOLUTION NO. 181-2021 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 03, SERIES OF 2021 OF ANDA, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Resolution No. 181-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

**WHEREAS**, the Local Development Council of Anda, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on December 9, 2021 through MDC Resolution No. 05, Series of 2021;

**WHEREAS**, the Supplemental Investment Program No. 3 covers fund augmentation for the Personal Services (Granting of Collective Negotiation Agreement Incentive to Municipal Employees);


