RESOLUTION NO. 800-2020

DECLARING ORDINANCE NO. 1, S-2020 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY WEAR OF FACE MASK AND STRINGENT PRACTICE OF PHYSICAL DISTANCING BY ALL PERSONS WHO ARE FOUND WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF ANDA, PANGASINAN DURING THE ENHANCED COMMUNITY QUARANTINE AND ANY EXTENSION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 1, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii), (5) (xii) of RA 7160; Presidential Proclamation Nos. 922 and 929, both of Series of 2020; DILG Memorandum Circular No. 2020-062; the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of June 3, 2020; and Provincial Ordinance No. 235-2020;

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer in her letter dated August 14, 2020;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;




