RESOLUTION NO. 801-2021

DECLARING MUNICIPAL ORDINANCE NO. 02-2020 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE THREE (3) PARCELS OF LAND OWNED BY SPOUSES CELSO SABINO JACINTO BAGAOISAN AND MINNIE BACORRO BAGAOISAN LOCATED AT BARANGAY TEBUEL, MANAOAG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Municipal Ordinance No. 02-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, Provincial Agrarian Reform Program Officer II, and Regional Officer of the Housing and Land Use Regulatory Board have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, though the Municipality of Manaoag has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 1996-2005, the same needs to be updated and all reclassification of lands shall be incorporated therein;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 02-2020 of the Sangguniang Bayan of Manaoag, Pangasinan, entitled "An Ordinance reclassifying the three (3) parcels of land owned by Spouses Celso Sabino Jacinto Bagaoisan and Minnie Bacorro Bagaoisan located at Barangay Tebuel, Manaoag, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
