PROVINCIAL RESOLUTION NO. 809-2020

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, the Provincial Government of Pangasinan is in need of a motor vehicle which shall be used in the operation and other related programs and projects particularly in “Abig Pangasinan Karaban” of the Province;

WHEREAS, the Provincial Government of Pangasinan intends to buy one (1) unit of motor vehicle with a total cost of P1,638,740.00 with the following specifications:

WHEREAS, the Provincial Government of Pangasinan shall comply with DILG Memorandum Circular No. 2014-155 dated December 17, 2014 which provides the “Guidelines on Motor Vehicles Acquisition by the Local Government Units” and DBM Budget Circular No. 2016-5 dated August 22, 2016 which “Revised the Guidelines on the Acquisition and Use of Government Motor Vehicles” in the procurement of the said vehicles;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to acquire said vehicle as a means to further enhance the services needed by the people;


