APPROVING SB RESOLUTION NO. 37, S-2020 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 03 CY 2020 AMOUNTING TO THREE MILLION THREE HUNDRED NINETY-NINE THOUSAND EIGHTY-FIVE PESOS (P3,399,085.00) FUNDED UNDER THE 20% MUNICIPAL DEVELOPMENT FUND OF BANI, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 37, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2020, endorsed to the Sangguniang Bayan for approval on June 18, 2020 by the MDC thru Resolution No. 2020-06 and was favorably acted upon by the Sangguniang Bayan on July 14, 2020 thru SB Resolution No. 37, S-2020;

WHEREAS, the Supplemental Investment Program No. 3 of the municipality covers programs/projects/activities to address the effects of COVID-19 pandemic to be funded from the realigned 20% Development Fund CY 2020. The realignment was also endorsed by the Local Development Council thru MDC Resolution No. 2020-05. This is in accordance with Local Budget Circular No. 124 dated March 26, 2020 and DILG-DBM Joint Memorandum Circular No. 01, dated March 27, 2020;
