APPROVING MUNICIPAL RESOLUTION NO. 213, S-2021 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 01 FOR CALENDAR YEAR 2021 OF THE LOCAL GOVERNMENT UNIT OF SAN NICOLAS, PANGASINAN”

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its SB Resolution No. 213, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of San Nicolas, Pangasinan prepared Supplemental Annual Investment Plan No. 01 containing therein programs/projects/activities to be funded by the realigned unexpended funds for the 20% Development Fund of CY 2020 and endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 02, Series of 2021 on July 26, 2021;

WHEREAS, the Municipal Supplemental Annual Investment Plan No. 1 with an investment requirement of Php4,290,232.88 covers fund for the construction, rehabilitation, and improvement of government buildings and other structures and the construction, improvement and widening of bridge at Barangay Malilion, San Nicolas, Pangasinan. Funding support for the implementation of the said projects is embodied in their Supplemental Budget No. 1, CY 2021, which was passed and approved by their Sangguniang Bayan on August 23, 2021 through Appropriation Ordinance No. 1, S-2021;




