PROVINCIAL RESOLUTION NO. 821-2021

WHEREAS, LANDBANK records show that a deposit account under the name of the Provincial Government of Pangasinan has been classified as “Dormant” status;

WHEREAS, the Provincial Government of Pangasinan still needs to maintain the said account for its financial transactions;

WHEREAS, it is necessary therefore, to request the reactivation of Account No. 2422-1052-40 under Account Name: PRDP Province of Pangasinan IBUILD GOP;

WHEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as it is hereby authorized, the Land Bank of the Philippines-Lingayen Branch to reactivate a dormant account of the Provincial Government of Pangasinan and further authorizing the Provincial Governor and the Provincial Treasurer to execute and sign all pertinent documents thereto;






