**APPROVING MUNICIPAL RESOLUTION NO. 67-2020 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF NATIVIDAD, PROVINCE OF PANGASINAN FOR CY-2020"**

**WHEREAS**, the Sangguniang Bayan of Natividad, Pangasinan submitted its Municipal Resolution No, 67-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Natividad, Pangasinan through MDC Resolution No. 04-2019 dated October 10, 2019 endorsed the CY 2020 Annual Investment Program of the municipality to the Sangguniang Bayan for approval. The Sangguniang Bayan approved the Annual Investment Program for CY 2020 thru Resolution No. 67-2020 dated February 24, 2020;

**WHEREAS**, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Natividad, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, and c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes the following: 1) Gender and Development Plan, Local Climate Change Action Plan, Peace and Order Plan, Annual Cultural Development Plan, Nutrition Plan, and 2) list of programs/projects/activities for Senior Citizens and Persons with Disabilities and Local Council for the Protection of Children;

**WHEREAS**, the AIP of Natividad has a total investment requirement amounting to P110,021,557.00 which will be funded from the municipality's CY 2020 Annual Budget which was passed and approved by their Sangguniang Bayan on February 24, 2020 through Appropriation Ordinance No. 01-2020;

**WHEREAS**, the development fund amounting to P20,691,311.40 which is allocated for development projects is twenty percent (20%) of the municipality's IRA (P103,456,557.00) for CY 2020. This is in accordance with Section 287 of RA 7160;

**WHEREAS**, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

**WHEREAS**, the programs, projects and activities of the 5% LDRRM Fund of the municipality amounting to P5,501,079.00 were based on Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRMF Plan of the municipality was reviewed and a certification was issued by the Office of Civil Defense (OCD) dated November 19, 2019;

**WHEREAS**, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

**WHEREAS**, the Gender and Development Plan of the municipality was already reviewed by the Department of Interior and Local Government (DILG) and found to be fully compliant in form and contents with the provisions of the Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated March 20, 2019;
