**APPROVING RESOLUTION NO. 2020-135 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 06 (SAIP NO. 06) OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO SIXTEEN MILLION EIGHT HUNDRED SEVENTY EIGHT THOUSAND SIX HUNDRED TWENTY THREE PESOS AND TWENTY NINE CENTAVOS (P16,878,623.29)"**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2020-135 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Alaminos City, Pangasinan had identified items in their Supplemental Investment Program No. 6 for CY 2020. This was endorsed to the Sangguniang Panlungsod for approval on July 23, 2020 by the City Development Council thru CDC Executive Committee Resolution No. 06, S-2020 and was favorably acted upon by the Sangguniang Panlungsod on July 28, 2020 thru SP Resolution No. 2020-135;

**WHEREAS**, the Supplemental Investment Program No. 6 of the city covers fund augmentation for the Personal Services (Hazard Pay) and Maintenance and Other Operating Expenses and Capital Outlay of some city offices and implementation of programs, projects and activities in response to the crisis due to COVID-19 pandemic;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
