DECLARING ORDINANCE NO. 2021-27 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING THE POSITION TITLE OF THE SUPERVISING ADMINISTRATIVE OFFICER (RECORDS OFFICER IV) – SALARY GRADE 22 TO SUPERVISING ADMINISTRATIVE OFFICER (BUDGET OFFICER IV) – SALARY GRADE 22 UNDER THE CITY BUDGET OFFICE OF THE LOCAL GOVERNMENT UNIT OF ALAMINOS CITY, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT


