**PROVINCIAL RESOLUTION NO. 83-2020**

**INTERPOSING NO OBJECTION TO THE INTENTION OF THE UNITED ASSOCIATION OF COCKPIT OWNERS AND OPERATORS OF THE PHILIPPINES, INC. (UACOOP) TO PROMOTE VARIOUS COCKFIGHTING EVENTS THROUGH BROADCASTING, LIVESTREAMING AND ANY OTHER SIMILAR PLATFORMS IN COMMERCIAL ESTABLISHMENTS WITHIN THE PROVINCE OF PANGASINAN**

**WHEREAS**, the United Association of Cockpit Owners and Operators of the Philippines, Inc. (UACOOP), represented by its President, Mr. Eric dela Rosa, manifested its intention through a letter addressed to the Provincial Governor, Amado I. Espino III, dated January 6, 2020, to promote various cockfighting events through broadcasting, livestreaming and any other similar platforms in commercial establishments within the Province of Pangasinan;

**WHEREAS**, the UACOOP is believed to be a duly registered association in the Philippines which is granted and authorized by the Games and Amusement Board to take live video coverage of cockfights and live stream the same to other authorized cockpits and off-cockpit establishments subject to the approval of the local government unit with jurisdiction over a particular area;

**WHEREAS**, due to the pacing of time brought by the use of modern technology, cockfighting events and/or activities in the Province of Pangasinan could now be possibly monitored through cellular phone, internet and other electronic equipment;

**WHEREAS**, subject to compliance with pertinent laws, existing rules, regulations and ordinances appurtenant to the granting of franchise by local government units to the association, the Sangguniang Panlalawigan interposes no objection to the said request;


