APPROVING RESOLUTION NO. 20-046 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 5 FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF LAOAC, PANGASINAN IN THE TOTAL AMOUNT OF THREE MILLION SEVEN HUNDRED SEVENTY-TWO THOUSAND SEVEN HUNDRED SIXTY FOUR PESOS & 02/100 (P3,772,764.02)"

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution NO. 20-046 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Laoac, Pangasinan has formulated and endorsed the municipality's Supplemental Annual Investment Program (SAIP) No. 5 thru MDC Resolution No. 2020-05 dated July 13, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on July 27, 2020 through Resolution No. 2020-046. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Annual Investment Program No. 5 with an investment requirement amounting to P3,772,764.02 covers fund augmentation of Personal Services for the implementation of the first tranche salary increase, hazard and overtime pay, MOOE, Capital Outlay of some offices and implementation of new development projects and COVID-19 response programs in the municipality;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
