APPROVING RESOLUTION NO. 2021-110 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2, CY 2021 OF SUAL, PANGASINAN AMOUNTING TO THIRTY-FIVE MILLION SIX HUNDRED SEVENTY THOUSAND THREE HUNDRED THIRTY-EIGHT PESOS (P35,670,338.00)"

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its SB Resolution No. 2021-110 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Development Council of Sual, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 2 through MDC Resolution No. 2, S-2021 dated June 29, 2021 to the Sangguniang Bayan for approval;

WHEREAS, the Supplemental Investment Program No. 2 of the municipality with an investment requirement amounting to of 35,670,338.00 covers fund augmentation for the personal services, maintenance and other operating expenses and capital outlays of various offices and implementation of development programs of the LGU;

WHEREAS, to support the implementation of the programs/projects embodied in the Supplemental Investment Program No. 2 the Sangguniang Bayan enacted Supplemental Budget No. 2 through Appropriation Ordinance No. 03 dated August 9, 2021;
