RESOLUTION NO. 834-2020

APPROVING RESOLUTION NO. 30, S-2020 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2021 AND OTHER ACTIVITIES RELATED TO THE ANNUAL BUDGET IN THE AMOUNT OF TWO HUNDRED THIRTY TWO MILLION SEVEN HUNDRED SIXTY TWO THOUSAND NINE HUNDRED NINETEEN PESOS (P232,762,919.00) OF THE MUNICIPALITY OF VILLASIS, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 30, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Villasis, Pangasinan has formulated the municipality’s Annual Investment Program for Calendar Year 2021 and endorsed thru MDC Resolution No. 04-2020 dated July 6, 2020 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan through Resolution No. 30, S-2020 dated July 21, 2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Villasis, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and

other service sectors and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, and c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes the following: 1) Gender and Development Plan, Local Climate Change Action Plan, Peace and Order Plan, Nutrition Action Plan, Annual Cultural Development Plan, and 2) list of programs/projects for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities to combat HIV-AIDS and to address the problem on illegal drugs;

WHEREAS, the AIP has a total investment requirement amounting to P232,762,919.00. This will be funded from the municipality's proposed 2021 Annual Budget which was passed and approved by their Sangguniang Bayan on July 21, 2020 through Appropriation Ordinance No. 03, Calendar Year 2020;

WHEREAS, the AIP is in accordance with Section 287 of RA 7160. More than twenty percent (20%) of the LGU's IRA (P177,811,919.00), which is equivalent to P36,000,000.00 is allocated for development projects;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the Gender and Development Plan of the municipality was already reviewed by the Department of Interior and Local Government (DILG) and found to be fully compliant in form and contents with the provisions of the Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG issued on June 19, 2020;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –


