**APPROVING RESOLUTION NO. 31, S-2020 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "APPROVING THE ANNUAL LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (ALDRRMFIP) FOR CALENDAR YEAR 2021 IN THE AMOUNT OF TEN MILLION SEVEN HUNDRED SIXTY TWO THOUSAND EIGHT HUNDRED NINETY FIVE PESOS AND NINETY FIVE CENTAVOS (P10,762,895.95) OF THE MUNICIPALITY OF VILLASIS, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 31, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Disaster Risk Reduction and Management Council of Villasis has adopted and endorsed the Annual Local Disaster Risk Reduction and Management Fund Investment Plan (LDRRMFIP) of the municipality for Calendar Year 2021 to the Sangguniang Bayan for approval thru MDRRMC Resolution No. 01-2020 dated July 3, 2020. The Sangguniang Bayan through Resolution No. 31, Series of 2020, dated July 21, 2020 approved the LDRRM Plan of the municipality;
