APPROVING RESOLUTION NO. 104-2020 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 03, CALENDAR YEAR 2020, INVOLVING A TOTAL AMOUNT OF SIX MILLION EIGHT HUNDRED SIXTY TWO THOUSAND ONE HUNDRED THIRTY ONE PESOS AND SIXTY ONE CENTAVOS (P6,862,131.61) FOR PURPOSES OF THE IMPLEMENTATION OF 2020 SALARY STANDARDIZATION LAW V (FIRST TRANCHE), 2019 PERFORMANCE-BASED BONUS, HAZARD PAY AND SPECIAL RISK ALLOWANCE OF LGU OFFICIALS AND EMPLOYEES OF ROSALES, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Resolution No, 104-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Rosales, Pangasinan has formulated and endorsed the municipality’s Supplemental Investment Program No. 3 thru MDC Resolution No. 0707, S-2020 dated July 7, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on July 15, 2020 through Resolution No. 104-2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 3 with an investment requirement amounting to P6,862,131.61 covers the implementation of salary increase, 2019 performance based bonus, hazard pay and special risk allowance of municipal officials and employees;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
