**APPROVING MUNICIPAL RESOLUTION NO. 117-2020 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02 OF THE MUNICIPALITY OF NATIVIDAD, PROVINCE OF PANGASINAN FOR CY 2020"**

**WHEREAS**, the Sangguniang Bayan of Natividad, Pangasinan submitted its Municipal Resolution No. 117-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Natividad, Pangasinan has formulated and endorsed the municipality's Supplemental Annual Investment Program No. 2 thru MDC Resolution No. 03-2020 dated June 25, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on July 6, 2020 through Resolution No. 117-2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Investment Program No. 2 with an investment requirement amounting to P8,040,512.58 fund augmentation of Personal Services for the implementation of the first tranche salary increase, MOOE, Capital Outlay of some offices and implementation of new development projects and COVID-19 response programs in the municipality;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
