#### **RESOLUTION NO. 84-2018**

APPROVING IN PART RESOLUTION NO. 309, S-2017 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF BAYAMBANG FOR CALENDAR YEAR 2018"

**WHEREAS**, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 309, Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Municipal Development Council of Bayambang, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2018. This was endorsed by the Council to the Sangguniang Bayan thru MDC Resolution No. 08-004, S-2017 dated August 30, 2017 and was favorably acted upon by the Sangguniang Bayan thru SB Resolution No. 309, S-2017 dated October 20, 2017;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC)

No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2015-1 dated July 23, 2015 as to format and content. The AIP of Bayambang, Pangasinan was prepared using the prescribed AIP Summary Form, and covers the following: a) all the regular budgetary requirements for the operation of the different offices broken down into: PS, MOOE and capital outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) DILG-endorsed Gender and Development Plan and Budget, d) Local Disaster Risk Reduction and Management Plan, e) Local Climate Change Action Plan, f) Peace and Order Plan, g) List of Programs, Projects and Activities (PPAs) for the Local Council for the Protection of Children, h) List of PPAs for Senior Citizens and Persons with Disabilities, and i) List of PPAs to Combat Acquired Immune Deficiency Syndrome (AIDS);

WHEREAS, the proposed AIP of Bayambang for CY 2018 has a total investment requirement of P5,186,317,902.04. Of this, the sum of P420,054,418.04 will be financed by the LGU as embodied in the municipality's proposed 2018 Annual Budget passed and approved by the Sangguniang Bayan Nos. 04 (for the Ordinance Appropriation through Special Economic Fund/P390.961.991.44) and 05 (for the Enterprise/P29,092,426.60), S-2017 dated October 20, 2017 while the remaining amount of P4,766,263,484.00 will be sourced from national government agencies;

**WHEREAS,** this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P227,397,900.00) amounting to P45479,580.00 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects;

WHEREAS, the programs/projects included in the Local Disaster Risk Reduction and Management Plan, amounting to P19,550,000.00 are in accordance with Section 21 of RA 10121 and NDRRMC-DBM and DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Joint Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);

WHEREAS, the LGU of Bayambang has also identified programs/projects/activities which are responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Plan had been reviewed by the Department of Interior and Local Government (DILG) Provincial Office and has been found to be compliant in form and content with the provisions of the Joint Memorandum Circular No. 2013-01 re: Guidelines on the Localization of Magna Carta for Women;

WHEREAS, the AIP of the subject municipality also included projects for funding from external sources such as NGAs;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order except the appropriations for Representation and Transportation Allowance (RATA) of some positions which are not considered Head/Assistant Department Heads as per Local Finance Committee opinion on their review of Appropriation Ordinance Nos. 04 and 05, S-2017 of said LGU;

WHEREFORE, in view of the foregoing, on motion of SP Members Angel M. Baniqued, Jr. and Generoso D. Tulagan, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jeanne Jinky C. Zaplan, duly seconded, it was –
