RESOLUTION NO. 840-2021

DECLARING MUNICIPAL ORDINANCE NO. 14-2021 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE PLANTILLA POSITION OF LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER I (ADMINISTRATIVE OFFICER II) OF LGU MANAOAG, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Municipal Ordinance No. 14-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Item 2.1 of NDRRMC-DILG-CSC Joint Memorandum Circular No. 2014-1 and Sections 76 and 447 (a) (i) (viii) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 14-2021 of the Sangguniang Bayan of Manaoag, Pangasinan, entitled “An Ordinance creating the plantilla position of Local Disaster Risk Reduction and Management Officer I (Administrative Officer II) of LGU Manaoag, Pangasinan” as within the conferred powers of the Sanggunian to enact;






