RESOLUTION NO. 85-2018

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2018 OF BAYAMBANG, PANGASINAN FOR GENERAL FUND INVOLVING A TOTAL APPROPRIATION OF P390,961,991.44 OPERATIVE IN PART

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Annual Budget for Calendar Year 2018 involving total appropriations of **P390,961,991.44** which was approved on October 20, 2017 through Appropriation Ordinance No. 04, S-2017;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The appropriation for Representation and Transportation Allowance (RATA) of the following positions shall not be allowed as they are not considered Assistant Department Heads:

- 2. The Ordinance creating twenty-eight (28) new positions in various offices should be submitted incorporating the qualifications and official duties and responsibilities of the positions;
- 3. The Ordinance transferring the position of Revenue Collection Clerk from the Office of the Municipal Engineer to Municipal Treasurer's Office should be submitted;
- 4. All procurements to be undertaken shall strictly be subject to the pertinent provisions of RA 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
- The disbursement of Loyalty Award to some municipal officials and employees shall be in accordance with Memorandum Circular No. 6 of the Civil Service Commission dated March 1, 2002;
- 6. The grant of step increment to some municipal officials and employees shall be in accordance with the DBM-CSC Joint Circular No. 1, S-2012 dated September 3, 2012;
- 7. The implementation of the Third Tranche Compensation Adjustment for Local Government Personnel shall be in accordance with specific guidelines to be issued by the Department of Budget and Management;
- All programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2018 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;
- The purchase of Motor Vehicle/s shall be subject to the provisions of Budget Circular No. 2017-1 of the Department of Budget and Management dated April 26, 2017 re "Revised Guidelines on the Acquisition and Use of Government Motor Vehicles";

- The projects funded under the 20% development fund shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re: "Updated Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment for Development Projects"; and
- 11. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality and shall notify the offices concerned of the actions taken thereon;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Angel M. Baniqued, Jr. and Generoso D. Tulagan, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN PART the Annual Budget for Calendar Year 2018 of Bayambang, Pangasinan** as of January 1, 2018 to December 31, 2018; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang;

RESOLVED, **FINALLY**, that a copy of this resolution be furnished the Municipal Budget Officer of Bayambang, Pangasinan, for his/her information and guidance.
