**APPROVING RESOLUTION NO. 2018-369-169 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2, FOR THE CALENDAR YEAR 2018 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2018-369-169 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, has conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has formulated the municipality's Supplemental Investment Program No. 2 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2018-03 dated November 19, 2018. This was subsequently approved by their Sangguniang Bayan thru SB Resolution No. 2018-369-169 dated November 28, 2018. This is in consonance to Section 106, 109 and 114 of the Local Government Code of 1991;

**WHEREAS**, the Supplemental Investment Program No. 2 of the municipality covers the construction of small water impounding project and fund augmentation for the maintenance and other operating expenses of various offices and disaster risk reduction and management activities of the municipality;


