APPROVING RESOLUTION NO. 48, S-2020 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) WITH A TOTAL AMOUNT OF P2,772,431,115.01, THE GENDER AND DEVELOPMENT (GAD) PLAN WITH A TOTAL AMOUNT OF P11,769,585.00 AND THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT (LDRRM) PLAN WITH A TOTAL AMOUNT OF P11,769,585.00, ALL FOR CY 2021 OF THE MUNICIPALITY OF BUGALLON, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 48, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bugallon, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2021. This was endorsed to the Sangguniang Bayan for approval on October 6, 2020 through MDC Resolution No. 04, S-2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Bugallon, Pangasinan was formulated following the

prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction programs, projects and activities, d) Local Climate Change Action Plan, e) Peace and Order Plan, f) Gender and Development Plan, g) Annual Procurement Plan, h) Tourism Plan, i) Nutrition Action Plan, j) Annual Cultural Development Plan, and k) List of Programs/Projects/Activities (PPAs) for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities, and PPAs to address the problems of illegal drugs and combat AIDS;

WHEREAS, the proposed AIP of Bugallon for CY 2021 has an investment requirement of P2,772,431,115.01. Funding support for the implementation of which is embodied in their 2021 proposed Annual Budget in the amount of P235,391,692.00, which was passed and approved by their Sangguniang Bayan on November 16, 2020 through Appropriation Ordinance No. 2020-04. The remaining amount of P2,537,039,423.01 is proposed for funding from national government agencies and other fund sources;

WHEREAS, this is also in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGU's IRA (P210,219,692.00), which is equivalent to P42,043,939.00 is allocated for development projects. The development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the attached Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P11,769,585.00), were based on Section 21 of RA 10121. The programs, projects and activities to be funded by 70% of the 5% LDRRM Fund in the amount of P8,238,710.00 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRM Plan of the municipality was reviewed and a certification was issued by the Office of Civil Defense (OCD) dated November 4, 2020;

WHEREAS, the LGU of Bugallon had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;


