RESOLUTION NO. 85-2022

DECLARING ORDINANCE NO. 12-2021 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED “AN ORDINANCE ABOLISHING NUTRITION OFFICER II AND CREATING THE POSITIONS OF RECORDS OFFICER II, ADMINISTRATIVE AIDE III, LOCAL LEGISLATIVE STAFF OFFICER III, NURSE I, SOCIAL WORKER OFFICER I, AGRICULTURIST I AND LOCAL DRRM ASSISTANT OF THE MUNICIPALITY OF BURGOS, PANGASINAN; SPECIFYING ITS POWERS AND DUTIES, APPROPRIATING FUND THEREFOR AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Ordinance No. 12-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREAS, however, the position title Social Worker Officer I should be changed to Social Welfare Officer I. Section 2 No. 5, Section 3, No. 5 on page, Section 4 No. 5, page 3, Section 5 letter E, page 4, Section 6 No. 5, page 7 should therefore be changed;


