**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM
NO. 7 OF THE PROVINCE OF PANGASINAN FOR CALENDAR
YEAR 2021**

WHEREAS, presented for consideration is the Supplemental Investment Program No. 7 of the Province of Pangasinan as endorsed by the Provincial Development Council through PDC Execom Resolution No. 17-21;

WHEREAS, Supplemental Investment Program No. 7 contains other priority programs, projects and activities that are not included in the approved 2020 Provincial Annual Investment Program of Pangasinan;

WHEREAS, said Supplemental Investment Program No. 7 contains fund augmentation for the Maintenance and Other Operating Expenses of various provincial offices and for the operation of Dairy Farm in Laoac, Pangasinan and Blood Bank and Other Provincial Blood and Voluntary Program; Public Affairs Fund; Purchase of Lot; Provincial Health Emergency and Response Team, Purchase of Hospital Equipment; and Terminal Leave Benefits for Employees;

WHEREAS, the total investment requirement for the full implementation of the said Supplemental Investment Program in the amount of P104,429,926.96 will be sourced from reversion of the following: reversion of obligated allotment, and current and continuing appropriations;

WHEREAS, said Supplemental Investment Program also includes details of various infrastructure projects funded from the CY 2021 20% Development Fund, realigned Local Disaster Risk Reduction and Management Fund CY 2021 and details of current LDRRM Fund;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


