## **RESOLUTION NO. 853-2020**

**DECLARING ORDINANCE NO. 08, S-2020 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN AND OTHER SUPPORTING DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE MUNICIPALITY OF CALASIAO, REPRESENTED BY ITS MUNICIPAL MAYOR, HON. JOSEPH ARMAN C. BAUZON, AND THE LAND BANK OF THE PHILIPPINES, REPRESENTED BY ITS ASSISTANT VICE PRESIDENT/HEAD, PANGASINAN LENDING CENTER, DEMETRIO P. ESPIRITU III, IN THE AMOUNT NOT EXCEEDING FORTY-EIGHT MILLION PESOS (P48,000,000.00) TO FUND THE LGU PROGRAM: (1) PROCUREMENT OF (A) BRAND-NEW SEVEN HUNDRED EIGHTY-TWO (782) UNITS ULTRAVIOLET MACHINE AND ONE HUNDRED (100) UNITS AIR PURIFIER MACHINE, (B) MEDICINES AND VITAMINS, (C) MEDICAL SUPPLIES AND EQUIPMENT, (D) RELIEF GOODS, AND (E) TENTS FOR ISOLATION FACILITY; AND (2) CONSTRUCTION OF ISOLATION FACILITIES, INCLUDED IN THE APPROVED ANNUAL/SUPPLEMENTAL INVESTMENT PROGRAM FOR CY 2020" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Ordinance No. 08, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Officer, and Provincial Accountant, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 22, 296, and 297 of RA 7160;

**WHEREAS**, the subject ordinance must be pursued in line with the provisions of RA 7160 which mandates that every loan application must comply with the requirements of the Department of Finance, the Bureau of Local Government Finance (Circular No. 1-2012) and the Bangko Sentral ng Pilipinas (BSP Circular No.769, S-2012);

**WHEREAS**, the proposed projects should be included in the LGU's next Supplemental Investment Program for CY 2020;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 08, S-2020 of the Sangguniang Bayan of **Calasiao**, Pangasinan, entitled “An Ordinance approving and ratifying the terms and conditions of the approved loan and other supporting documents pertaining to the loan entered into by and between the Municipality of Calasiao, represented by its Municipal Mayor, Hon. Joseph Arman C. Bauzon, and the Land Bank of the Philippines, represented by its Assistant Vice President/Head Pangasinan Lending Center, Demetrio P. Espiritu III, in the amount not exceeding Forty-Eight Million Pesos (P48,000,000.00) to fund the LGU Program: (1) Procurement of (a) brand-new seven hundred eighty-two (782) units ultraviolet machine and one hundred (100) units air purifier machine, (b) medicines and vitamins, (c) medical supplies and equipment, (d) relief goods, and (e) tents for isolation facility; and (2) construction of isolation facilities, included in the approved Annual/Supplemental Investment Program for CY 2020” as within the conferred powers of the Sangguniang Bayan to enact;

**RESOLVED FURTHER**, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Calasiao, Pangasinan, for its information and guidance.
