DECLARING ORDINANCE NO. 20-07 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING THE BINALATONGAN COMMUNITY COLLEGE-BOARD OF TRUSTEES (BCC-BOT) RESOLUTION NO. 121, S-2020 AND ALLOCATING 7,008 SQ. M. PORTION OF THE CITY'S REAL ESTATE PROPERTY SITUATION AT BARANGAY ANO, SAN CARLOS CITY, PANGASINAN BEARING T.C.T. NO. 030-2016000469 FOR THE PURPOSE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 20-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 458 (a) (5) (x) of RA 7160;

WHEREAS, the administration/management of the Binalatongan Community College was included in the LGU's Annual Investment Program for CY 2020 and funded by the LGU's 2020 Annual Budget;

WHEREAS, the establishment and construction of the Binalatongan Community College Campus and Building was considered in the LGU's Annual Investment Program for CY 2020 and proposed to be funded from external sources;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject ordinance in order;




