RESOLUTION NO. 856-2020

DECLARING ORDINANCE NO. 20-09 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING ALL PERSONS, WHETHER MINOR OR OF LEGAL AGE, TO WEAR FACE MASK IN PUBLIC PLACES WITHIN THE CITY OF SAN CARLOS (PANGASINAN)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 20-09 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 458 (a) (1) (viii), (5) (xii) of RA 7160; Presidential Proclamation No. 922, S-2020; DILG Memorandum Circular No. 2020-071; Provincial Ordinance No. 240-2020; Executive Order No. 0033-2020 of the Office of the Governor of Pangasinan; and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –




