**RESOLUTION NO. 858-2020**

**DECLARING ORDINANCE NO. 20-11 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE OBSERVANCE OF PHYSICAL DISTANCING IN ALL PUBLIC PLACES AND COMMUNAL AREAS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 20-11 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 458 (a) (1) (iii), (5) (xii) of RA 7160; Presidential Proclamation No. 922, S-2020; Provincial Ordinance No. 240-2020 and Section 1 (E) of Executive Order No. 0033-2020 (Implementing Guidelines on Modified General Community Quarantine in the Province of Pangasinan);

**WHEREAS**, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –




