DECLARING ORDINANCE NO. 9, S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT OFFICE (MDRRMO) AND PROVIDING BUDGETARY REQUIREMENTS THEREOF AND ADOPTING POLICIES TO GOVERN ITS ORGANIZATIONAL STRUCTURE AND STAFFING PATTERNS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 9, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 76, 443 (c) (2) and 447 (a) (1) (viii) of RA 7160 and Section 12 of RA 10121 (Philippine Disaster Risk Reduction and Management Act of 2010);

**WHEREAS**, the qualifications of Municipal Government Department Head (Municipal Disaster Risk Reduction Management Officer), SG-24 should be in accordance with the provisions of Items 6.2 of NDRRMC-DILG-DBM-CSC Joint Memo Circular No. 2014-1;
