**RESOLUTION NO. 861-2020**

**DECLARING ORDINANCE NO. 11, S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “AN ORDINANCE MANDATING ALL PERSONS TO WEAR FACE MASKS AT ALL TIMES IN ALL PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN DURING ALL LEVELS OF COMMUNITY QUARANTINE IMPLEMENTING PENALTIES THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 11, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071; Provincial Ordinance No. 240-2020; the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines; and Section 18 of Executive Order No. 0033-2020 (Implementing Guidelines on Modified General Community Quarantine in the Province of Pangasinan);

**WHEREAS**, the Sangguniang Bayan of San Fabian shall consider the points raised by the Provincial Legal Officer stated in her opinion dated August 29, 2020;

**WHEREAS**, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;


