**APPROVING RESOLUTION NO. 059-2021 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 FOR CY 2021 OF THE MUNICIPALITY OF LABRADOR, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its SB Resolution No. 059-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that that the same is in pursuant to Sections 106, 109 and 114 of R. A. No. 7160;

**WHEREAS** the Local Development Council of Labrador, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on September 6, 2021 by the Municipal Development Council through MDC Resolution No. 02, S-2021;

**WHEREAS**, the Supplemental Investment Program No. 2 covers fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of the Executive Services and implementation of the programs/projects to address the impact of COVID-19;

Funding support for the implementation of the same is embodied in the Supplemental Budget No. 2 for CY 2021 which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 02-2021 on September 6, 2021 and approved by the Municipal Mayor on September 10, 2021;
