RESOLUTION NO. 864-2020

DECLARING MUNICIPAL ORDINANCE NO. 2020-06 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING CERTAIN PROVISION OF MUNICIPAL ORDINANCE NO. 2020-02 ENTITLED, “AN ORDINANCE REQUIRING THE MANDATORY WEARING OF FACE MASK BY ALL PERSONS IN PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BINALONAN, PANGASINAN DURING THE ENHANCED COMMUNITY QUARANTINE AND FOR ANY EXTENSION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2020-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) of RA 7160;

WHEREAS, the power of the Sangguniang Bayan to enact ordinances and approve resolutions carries with it the power to amend, revoke, modify or repeal the same;

WHEREAS, the Sanggunian shall consider the points raised by the Provincial Legal Officer stated in her opinion dated September 02, 2020;




