RESOLUTION NO. 864-2021

DECLARING ORDINANCE NO. 103, S-2021 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING RESPONSE MECHANISM AND PROTOCOL IN HANDLING GENDER-BASED VIOLENCE AND RAPE CASES IN THE MUNICIPALITY OF LINGAYEN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Municipal Ordinance No. 103, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 17 (a) (iv) of R.A. No. 7160; R.A. No. 9710 (Magna Carta of Women); R.A. No. 11313 (Safe Spaces Act); R.A. No. 10175 (Cybercrime Prevention Act of 2012); R.A. No. 9208 (Anti-Trafficking in Persons Act of 2003); R.A. No. 9262 (Anti-Violence Against Women and Their Children Act of 2004); R.A. No. 8505 (Rape Victim Assistance and Protection Act of 1998); R.A. No. 7877 (Anti-Sexual Harassment Act of 1995); and Joint Memorandum Circular No. 2010-2 dated December 9, 2010, entitled “Guidelines in the Establishment of a Violence Against Women (VAW) Desk in Every Barangay”;
