DECLARING MUNICIPAL ORDINANCE NO. 2020-07 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN. ENTITLED "AN ORDINANCE AMENDING CERTAIN PROVISION OF MUNICIPAL ORDINANCE NO. 2020-03 ENTITLED, "AN ORDINANCE REOUIRING THE STRICT **PRACTICE** OBSERVANCE OF PHYSICAL AND/OR SOCIAL DISTANCING BY ALL PERSONS IN PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BINALONAN, PANGASINAN DURING THE **ENHANCED COMMUNITY QUARANTINE AND FOR ANY EXTENSION THEREOF" AS** WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG **BAYAN TO ENACT**

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2020-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (1) (iii), (5) (xii) of RA 7160;

WHEREAS, the power of the Sangguniang Bayan to enact ordinance and approve resolutions carries with it the power to amend, revoke, modify or repeal the same;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
