RESOLUTION NO. 868-2020

DECLARING ORDINANCE NO. 07-2020 OF THE SANGGUNIANG ENTITLED OF ROSALES, PANGASINAN, BAYAN **AGAINST** PROHIBITING DISCRIMINATION **ORDINANCE** PERSONS INFECTED, AS SUSPECTED AND PROBABLE AND CONFIRMED CASES DUE TO THE CORONA VIRUS DISEASE WORKERS **INCLUDING** HEALTH (COVID-19) FRONTLINERS AND IMPOSING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 07-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (5) (xii) of RA 7160; and Section 5 (General Provisions) of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
