**RESOLUTION NO. 869-2020**

**DECLARING ORDINANCE NO. 09-2020 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "AN ORDINANCE MANDATING ALL ESTABLISHMENTS ENGAGE IN THE LEASE OR RENTAL OF APARTMENT, ROOM UNITS, DORMITORIES AND THE LIKE TO REQUIRE THEIR RESPECTIVE RENTERS (LESSEES) TO SUBMIT THEIR BARANGAY CERTIFICATES AND MEDICAL HEALTH CERTIFICATES FROM THE RURAL HEALTH UNIT OF THE MUNICIPALITY OF ROSALES, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 09-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (3) (ii), (5) (xii) of RA 7160;

**WHEREAS**, the Sanggunian shall consider the points raised by the Provincial Legal Officer stated in her opinion dated August 28, 2020;

**WHEREAS**, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;




