### **RESOLUTION NO. 872-2020**

#### APPROVING RESOLUTION NO. 55, S-2020 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 02, CY-2020 OF DASOL, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Resolution No. 55, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Dasol, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on June 23, 2020 by the Municipal Development Council Executive Committee thru MDC ExeCom Resolution No. 2, S-2020 and was favorably acted upon by the Sangguniang Bayan on July 21, 2020 thru SB Resolution No. 55, S-2020;

**WHEREAS**, the said Supplemental Investment Program covers fund augmentation for the Personal Services (First Trance Salary Standardization Law of 2019 and COVID 19 Hazard Pay) and Maintenance and Other Operating Expenses and implementation of development projects and disaster risk reduction programs of the municipality;

WHEREAS, the said Supplemental Investment Program has an investment requirement of P6,949,138.96. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 02 for Calendar Year 2020, which was passed and approved by their Sangguniang Bayan on July 21, 2020 thru Appropriation Ordinance No. 168 and approved by the Municipal Mayor on August 10, 2020;
