**RESOLUTION NO. 873-2021**

**DECLARING ORDINANCE NO. 2021-22 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE PROHIBITING SEXUAL HARASSMENT IN ANY FORM IN THE CITY OF ALAMINOS, PANGASINAN PURSUANT TO REPUBLIC ACT NO. 7877, OTHERWISE KNOWN AS THE “ANTI-SEXUAL HARASSMENT ACT OF 1995” AND REPUBLIC ACT NO. 11313, OTHERWISE KNOWN AS THE “SAFE SPACES ACT OF 2019” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2021-22 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 17 (2) (iv) (4) of R.A. No. 7160; R.A. No. 11313 or “ Safe Spaces Act”; R.A. No. 7877 or “ Anti-Sexual Harassment Act of 1995”; R.A. No. 9208 or “ Anti-Trafficking in Persons Act of 2003; R.A. No. 9262 or “ Anti- Violence Against Women and Their Children Act of 2004”; R.A. No. 9995 or “Anti-Photo and Video Voyeurism Act of 2009; R.A. No. 9775 or “Anti-Child Pornography Act of 2009; and R.A. No. 7610 or “Special Protection of Children Against Abuse, Exploitation and Discrimination Act;

**WHEREAS**, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c), and 511(a) of RA 7160 are complied with;


