RESOLUTION NO. 878-2021

DECLARING ORDINANCE NO. 071-2021 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED “AN ORDINANCE ADOPTING REPUBLIC ACT NO. 9482, OTHERWISE KNOWN AS THE ANTI RABIES ACT OF 2007 AND PROVIDING GUIDELINES FOR ITS EFFECTIVE IMPLEMENTATION IN THE MUNICIPALITY OF LABRADOR, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Municipal Ordinance No. 071-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 447 (a) (4) (viii) of R.A. No. 7160; R.A. No. 8485 or the “Animal Welfare Act of 1998”; and R.A. No. 9482 or the “Anti-Rabies Act of 2007;

WHEREAS, subject ordinance shall take effect after the requirements of public hearing, posting and publication pursuant to Sections 187, 188, 59 (c), and 511(a) of RA 7160 are complied with;
