PROVINCIAL ORDINANCE NO. 88-99

AN ORDINANCE DESIGNATING A NUMBER SEQUENCE FOR EACH TERM OF THE SANGGUNIANG PANLALAWIGAN OF PANGASINAN BEGINNING FROM THE YEAR R.A. 7160 WAS IMPLEMENTED

EXPLANATORY NOTE

Pursuant to Section 48 of R.A. No. 7160 otherwise known as the Local Government Code of 1991, the legislative power of provincial governments shall be exercised by the sangguniang panlalawigan.

It shall be noted that the new nomenclature was given effective on July 1, 1992 by virtue of the implementation of the subject Local Government Code.

To uphold the dignity and to distinguish every term of the Sangguniang Panlalawigan, it is constitutive and appropriate to designate a number sequence for each set of the Sanggunian. Hence, this Ordinance.

BE IT ENACTED by the Sangguniang Panlalawigan of Pangasinan in session assembled that:

Section 1. DECLARATION OF POLICY. - It shall be the policy of the provincial government of Pangasinan to designate its local legislative body as "**FIRST SANGGUNIANG PANLALAWIGAN**" for the term July 1, 1992 to June 30, 1995; "**SECOND SANGGUNIANG PANLALAWIGAN**" for the term July 1, 1995 to June 30, 1998; "**THIRD SANGGUNIANG PANLALAWIGAN**" for the term July 1, 1998 to June 30, 2001; and the subsequent terms to follow suit.


