WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Resolution No. 2018-24 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, has conducted initial review and study on said resolution and found out that the Local Development Council of San Manuel, Pangasinan has formulated the municipality's Supplemental Investment Program No. 1 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 02, S-2018 dated August 30, 2018. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 2018-24 dated September 7, 2018. This is in consonance to Section 106, 109 and 114 of the Local Government Code of 1991;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality with an investment requirement amounting to P11,583,866.30 covers the fund augmentation for personal services and implementation of existing programs/activities of the municipality;
