RESOLUTION NO. 88-2022

DECLARING ORDINANCE NO. 06, S-2021 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE PLANTILLA POSITIONS OF ADMINISTRATIVE OFFICER III (RECORDS OFFICER II), ADMINISTRATIVE AIDE III (DRIVER I), TICKET CHECKER, ENGINEER III, TAX MAPPING AIDE, SR. ADMINISTRATIVE ASST. II (COMPUTER OPERATOR IV), ADMINISTRATIVE ASSISTANT I (BOOK BINDER III), LOCAL LEGISLATIVE STAFF ASSISTANT III AND LOCAL LEGISLATIVE STAFF OFFICER II UNDER THE DIFFERENT OFFICES OF THE LOCAL GOVERNMENT OF INFANTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Ordinance No. 06, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREAS, however, Section 2 (a) of the Ordinance should be changed from Office of the Municipal Budget Office to Office of the Municipal Assessor where one Tax Mapping Aide is created;


