APPROVING RESOLUTION NO. 50, S-2020 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED "APPROVING THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPAL SUPPLEMENTAL BUDGET NO. 4, S-2020 OF THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Resolution No. 50, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Quintin, Pangasinan has formulated and endorsed the municipality's Supplemental Annual Investment Program (SAIP) No. 4 thru MDC Executive Committee Resolution No. 4, S-2020 dated July, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on July 27, 2020 through Resolution No. 50, S-2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Annual Investment Program No. 4 with an investment requirement amounting to P1,533,330.00 covers the provision of hazard pay benefits of employees and performance based bonus to all qualified officials and employees of the municipality;
