RESOLUTION NO. 882-2020

DECLARING MUNICIPAL ORDINANCE NO. 2019-003 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING A LAND COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. T-0282016000836 WITH AN AREA OF FIVE HUNDRED (500) SQUARE METERS LOCATED IN BARANGAY MAGALLANES, TAYUG, PANGASINAN FROM RESIDENTIAL LAND USE INTO COMMERCIAL LAND USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Municipal Ordinance No. 2019-003 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Officer, Department of Agrarian Reform, and Housing and Land Use Regulatory Board, have conducted initial review and study on said municipal ordinance and found out that the Municipality of Tayug has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan 2016-2025;

WHEREAS, the Municipality of Tayug shall integrate through amendment, the rezoning of the 500 square meter lot located in Barangay Magallanes, Tayug, Pangasinan in the LGUs Zoning Ordinance and Comprehensive Land Use Plan 2016-2025;


