DECLARING MUNICIPAL ORDINANCE NO. 4, S-2021 OF THE SANGGUNIANG BAYAN OF **BAUTISTA**, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING FRANCHISE TO UNITED ASSOCIATION OF COCKPIT **OWNERS** AND PHILIPPINES. **OPERATORS** OF THE **INCORPORATED.** (UACOOP) TO BROADCAST LIVE AND DATA STREAMED **COCKFIGHTING ACTIVITIES AND DERBIES AT COMMERCIAL** ESTABLISHMENT AND TO ESTABLISH, OPERATE, AND MAINTAIN AN OFF-SITE COCKPIT BETTING STATIONS IN THE MUNICIPALITY OF BAUTISTA, PANGASINAN" AS WITHIN THE **CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Municipal Ordinance No. 4, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 447 (a) (3) (v) of R.A. No. 7160, Section 8 of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines (Updated as of September 23, 2021), Pangasinan Provincial Ordinance Nos. 235-2020, as amended and 242-2020;

WHEREAS, subject ordinance shall take effect after the requirements of public hearing, posting and publication pursuant to Sections 187, 188, 59 (c), and 511(a) of RA 7160 are complied with;
