RESOLUTION NO. 884-2021

DECLARING MUNICIPAL ORDINANCE NO. 2021-02 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “AN ORDINANCE ENACTING THE MUNICIPAL ENVIRONMENT CODE OF BALUNGAO, PANGASINAN, IMPOSING PENALTIES FOR VIOLATIONS AND APPROPRIATING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Municipal Ordinance No. 2021-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Sections 16, 17 (2) (vi) and 447 (1) (iii) and (vi) of R.A. No. 7160, Section 8 of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines (Updated as of September 23, 2021), Pangasinan Provincial Ordinance Nos. 235-2020, as amended and 242-2020;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511(a) of RA 7160 are complied with;


